University of Belgrade – Office of International Relations announces the Public Call for expressions of interest for the appointment of an External Expert as guest lecturer at new accredited master study programme "Financial Management, Audit and Managerial Accounting" at the Faculty of Organizational Sciences of the University of Belgrade.

Professional profile of the successful candidate

- University master degree in public or business administration, economics or political sciences;
- A minimum of five years, preferably seven years, of professional experience with Public Financial Management (PFM) and Public Administration Reform (PAR), especially in: Implementing program and performance-based budgeting; and Developing and delivering training programs for public sector staff at all levels;
- Experience with the Serbian public sector, especially with public administration reform, would be considered as advantage;
- A minimum of three, preferably five years of experience in Team Leadership and Project Management in the fields of PFM, good governance and/or local development;
- Experience in developing reports on the implementation of strategies, policies or programmes for various target audiences, etc. would be considered as advantage;
- Experience in Monitoring and Evaluation (M&E): Establishing performance monitoring systems, Designing supporting IT systems, Evaluating policy and project effectiveness, would be an asset;
- Excellent communication, analytical and organizational skills;
- Excellent writing and editing skills in Serbian and English;
- Citizen of Serbia, Albania or EU country

Responsibilities

External Expert will be appointed as guest lecturer at new accredited master study programme "Financial Management, Audit and Managerial Accounting" at the Faculty of Organizational Sciences of the University of Belgrade to deliver 5 lectures and workshops (4 hours each) as part of the course Budgeting and Control on following themes: Implementing program and performance-based budgeting, Performance monitoring systems, Supporting IT systems, Evaluating policies and budgets and Reporting.

External Expert will perform task / lectures at the Faculty of Organizational Sciences of the University of Belgrade during November and December 2018.
